Public participation

1 member of the public was present to talk about the rubbish in Tideford car park in Church Road. Cornwall Council have now tidied up the car park. It was also reported that the hedges along the footpath up the side of the car park are overgrown. The Clerk will report this.

2. Apologies for absence

Cllr J Foot and Cllr A Gowing sent their apologies. These absences were approved by all.

3. Approval of the Minutes of the meeting held on 25 June 2018

It was proposed by Cllr Pipe and seconded by Cllr Willis the minutes be approved. All were in favour and the minutes were signed by Cllr Hodge.

4. Councillors reports

- **4.1** Cllr Foot had given his apologies.
- **4.2** Cllr Willis talked about a project in the planning service which is focusing on improving direct communication between Parish Councils and the Planning and Enforcement departments in Cornwall Council.
- **4.3** Cllr Chilton and Cllr Hodge talked about the last SARS meeting. The main areas discussed were the consultation on the cost of the bridge. Speeding in and around Saltash and Polbathic. There was also mention about there not being a sufficient number of houses on Broadmoor Farm, due to a main gas pipe running under the land which restricts the development.

5.2 Highways – ongoing issues

5.2.1 A38 Tideford

Last meeting was very well attended by the public. Positive steps are being taken and it is gaining positive momentum.

5.2.2 Treland fencing and Branchecoombe corner

Ongoing. Clerk to continue to chase.

5.2.3 Doctors Lane closure (Port Eliot)

Ongoing. Clerk to continue to chase.

5.2.4 Traffic – Gateway funding

Two applications have been made; one for the Old White House and the other for a feasibility study for a traffic calming study in Polbathic.

5.3 Local Bus Services – Cllr Willis

Cllr Willis reported that the 72 service that runs as a double decker in the summer and then becomes as a single decker in the winter has been seen as a single decker during July? Plymouth Citybus have been asked to reinstate the 72 service through St Germans for the winter, but they have said this is highly unlikely for this winter. GWR franchise is not going to be split, it will remain as one. Cllr Chilton raised a concern about the bus service stopping on a residential drive in Bethany which is causing damage. It has been asked that the bus stops at the post box/parish noticeboard in Bethany. Great Western have also launched a new train without any disabled facilities!

5.9 Litter in Tideford

The public car park in Church Road in Tideford has now been cleared. The bins will be removed. The Clerk will contact the litter contractor for the park to ask where the rubbish collected is then disposed of.

5.10 SSE Contract renewal (Tideford lighting)

New 24 month contract agreed with a new monthly amount of £6.20 inclusive of VAT. This was proposed by Cllr Pipe and seconded by Cllr Mackeen. All were in agreement.

5.11 St Germans Rec

The Parish Council were asked to provide a bin in the picnic area and to arrange for collection of the rubbish from both bins. It was felt by the Councillors that the Parish Council cannot take on the responsibility of providing the bin or of removing the litter, but the Clerk

will provide some contact details. This was proposed by Cllr Hodge and seconded by Cllr Pipe. All were in favour.

5.12 Clerks August leave

It was agreed that Cllr Hodge will provide contact for planning enquiries and Cllr Mackeen for burials.

6. Playparks

6.1 St Germans

6.1.1 Cllr Mackeen inspected Treland and made a repair to the wobbly bench and a 'Tag' was removed from a picnic table. Cllr Witton will do the next inspection. The new mulch work will start on Monday 10th September 2018.

6.2 Tideford

6.2.1 Cllr Hodge reported on the main gate needs replacing and the post is wobbly, benches need attention and there was broken glass in the basketball court which has been cleared. The younger playpark needs attention. Cllr Hodge did the last inspection and Cllr Skelton to do the next. Cllr Hodge, Cllr Gomersall and Cllr Skelton will meet on Saturday 4th August to review the issues that need prompt attention.

- **9.1.4 PA18/05459 Old Treboul, St Germans** Amendments to PA16/05492 (Reuse of a dilapidated farmhouse and barns to provide two dwellings together with annexe and studio accommodation) involving the addition of a garage/workshop ancillary to the development. It was proposed by Cllr Pipe to support this amended application, seconded by Cllr Mackeen. The majority of Councillors were in favour with one abstinence.
- **9.1.5** PA18/05705 Padderbury Farm, Menheniot The construction of a general purpose agricultural storage building (18.3m x 12.2m). It was proposed by Cllr Hodge to support this application, seconded by Cllr Mackeen. All were in favour.
- **9.1.6 PA18/05976 The Corn Barn, Trenithick Farm, Bethany** Conversion of barn to dwelling (Revised design to application no. PA16/03650). It was proposed by Cllr Pipe to support this application, seconded by Cllr Chilton. All were in favour.
- **9.1.7 PA18/05535 Furze Park, Trerulefoot, Bethany PL12 5DE** To convert the disused barn to an annexe.

It was proposed by Cllr Pipe to support this application, seconded by Cllr Witton. All were in favour.

9.1.8 PA18/06237 - The Old Store House Church Street St Germans - Alterations and refurbishment of the main house (private dwelling) and outbuildings with localised landscaping and a new garden studio in the upper garden.

The Councillors have asked the Clerk to arrange a site visit to clarify the intrusiveness of the garden studio over neighbouring properties.

9.1.9 PA18/05743 - Penquite Farm Trerulefoot - General purpose agricultural building to store agricultural machinery.

It was proposed by Cllr Pipe to support this application, seconded by Cllr Barnes. All were in favour.

9.1.10 Polbathic Old Ironworks – public open space

The Councillors would like to see a larger open space with perimeter fencing on site for the children to access.
