- **5. Review 2020-21 regulations.** The regulations have been circulated. They will be amended to reflect what's been agreed in this meeting. Otherwise, no change. Proposed by Cllr Chilton, seconded by Cllr Mackeen. Agreed by all.
- **6. Review maximum size of memorial tablets in memorial garden**. It was agreed that with immediate effect the maximum tablet size will be 46x30cm in the memorial garden. Proposed by Cllr Chilton, seconded by Cllr Mackeen. Agreed by all.
- **Natural burials** (Cllr Gomersall) a discussion took place about natural burials and that they seem to be getting more popular now-a-days. The Clerk has been asked to look at the options with the existing site and also if there was a possibility of buying a neighbouring field to offer a more natural burial environment.

8. To agree and make recommendations to the Parish Council

It was agreed to make the following recommendations back to full council to accept: ~the maximum memorial tablet size for the memorial garden will be 46x30cm.

- ~to keep prices the same for 2021-22 (from 2020-21). Review in March 2022.
- ~to only amend the regulations with the points raised in this meeting.
- ~to look into offering natural burials on existing site and possibly neighbouring land.
